- Develop accessible learning resources in partnership with multidisciplinary teams
- Manage the technology of the school:
 - · Google Administrator for all staff and students
 - Oversee technology budget
 - Purchase, install and manage all software, licensing and subscriptions
 - Tech support for the organization
 - Set up and support for all devices (SEA equipment, Smartboards, Chromebooks, iPads, Windows laptops, printers and peripherals) for students and staff
 - Device management (Apple School Manager, Chrome Management and Mosyle)
- Support the backend of the Student Information System (SIS), Permission Click and the IEP and Report Card platform
- Support webinars, school events, video production
- Support network management and cyber security
- Maintain the school website and social media platforms
- Complete other related duties as assigned.
