# 5. UPDATES

# 5.1 HOLLAND BLOORVIEW (S. Wong)

S. Wong, shared that Holland Bloorview Kids Rehab began admitting adult clients April 16, 2021. As a measure to support other hospitals all children's hospitals are now accepting adult clients. This is a substantial change for the Hospital.

S. Wong also shared with the Board members that the Hospital continues to take several measures to keep all safe in coordination with the school. Measures implemented include, testing for our students.

# 5.2 PRINCIPAL'S REPORT (S. Nauman)

S. Nauman informed members of the Board that Bloorview School continues to manage all of the pivots without missing a beat. On April 6, with 30 minutes notice that in person schools were closing, staff were able to organize and send home technology, OT materials and mobility devices, and were online and engaged with students on April 7. Learning remained virtual for the week of April 10. During this time, all parents were consulted and with the support of Holland Bloorview offered asymptomatic testing in advance of return to in person learning on April 26.

S. Nauman shared with the Board members that since the beginning of the pandemic Bloorview School has had 11 students who have tested positive for COVID-19, and one occasional staff member. To date there has been no transmission within the school. Parents have supported the school's efforts by consistently screening their children daily. Since April 26, parents have also been asked to send masks for their children if there are no medical reasons not to. Staff have been working hard to teach students proper mask etiquette and students are doing an amazing job learning to wear masks. We have 55 in person and 11 virtually.

BSA had completed our admissions process for September and have offered 24 placements. We are set to begin September with 72 students (our maximum). Staffing is well under way with seven new teachers coming on board. We will be starting their orientation with a virtual welcome webinar on May 19.

# 5.3 SUPERVISORY OFFICER'S REPORT (M. O'Keefe)

M. O'Keefe emphasized in that there is considerable concern in the education community about student and staff mental health needs both during and after the pandemic.

The bursary application process has been extended to allow for more applicants.

M. O'Keefe also shared that there is considerable concern among regular school boards regarding the disengagement of students (especially with the reality that in some cases this disengagement will be permanent) from the education system.
